



Statement of consent for processing personal data

Video and audio recording of the online meetings organised by ARACIS within the external evaluation visit at the University

The Romanian Agency for Quality Assurance in Higher Education, hereinafter referred to as ARACIS, is a personal data operator and processes this data, in accordance with the EU Regulation 2016/679.

According to the provisions of *the EU Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data*, ARACIS has the obligation to process your personal data (provided to us by you), safely and only for the specified purposes.

The purpose of data collection: keeping evidence on the conduct of external evaluation commission online meetings

Recipients of personal data processing: Members of ARACIS Executive Board, ARACIS SEISAAC employees, ARACIS IT Compartment employees

The person responsible with the recording: for the external evaluation commission online meetings – technical secretary of the commission

Estimated storage and processing period: 10 years

Type of personal data: the voice of the participants in the meeting, video image of the participants in the meeting and chat discussions

The right of the persons concerned:

- the right to be informed;
- the right to access data. Please make a request if you want a confirmation that your data is processed and if you want to see how it is managed;
- the right of rectification. Please inform us regarding any data you would like us to rectify and we will respond you within a maximum of one month from the date of the request;
- the right to delete. You can exercise your right to delete your personal data in certain situations (for example, if the data is no longer needed in relation to the purpose for which it was created or if you withdraw your consent);



- the right to restrict processing. You can inform us if we can keep your data, but we need to stop processing. This request may be made when you want to check the accuracy of the data or the purpose of its processing;
- the right to data portability. We will do everything we can to provide information in a portable format, but it is unlikely that we will be able to create automated systems to do this;
- the right to object. If we can, we will stop processing your data if you object to the processing, based on a legitimate interest or if there are reasons in your personal situation that cause you to exercise this right (including profiling). We will stop processing your data if you object to the processing for research and statistical purposes;
- the right not to be subject to a decision based solely on automatic processing, including profiling.

You also have the right to withdraw your consent at any time, in written form.

To exercise these rights, please contact ARACIS, using the e-mail address: gdpr@aracis.ro, with the condition that the data subject (applicant) can be identified, and the request is not unfounded and/ or abusive. The request of the data subject can also be submitted in letter format to the postal address: ARACIS, Bd. Mărăști no. 59, Bucharest, Romania. The maximum response time is 30 days.

If you do not want to be recorded video (the audio recording is required to attend the meeting), you can deactivate your video image from the appropriate video conferencing application button at the beginning of the online meeting.
